Tuition Reduction Program for 2011-2012 School Year

Using family feedback, the Administration and the Development Committee have determined the following Tuition Reduction Program for the upcoming school year: There is no limit of how much your family can earn for tuition reimbursement. Whatever % is earned through these programs will be credited towards tuition for the current school year, or if paid, the following school year. You do not have to participate in any of these programs if you do not want to. These are just opportunities for you to earn money that can be applied as a credit towards tuition. Remember, there is no mandatory fundraising this year. Any tuition reduction credit will be posted to your account as they are received. Tuition statements will be sent periodically to families.

- **\$20 Lottery Ticket**- winnings from evening daily lottery- This year we will have 2 sales. Tickets will be sold during the Fall and Spring.
- **The \$20 Fall Lottery Program** The Lottery will run from October 17, 2011 to February 14, 2012. 1,000 tickets will be available. Sunday thru Friday payout is \$50/day; Saturday - \$100; Halloween and New Years Day - \$250; Thanksgiving and Christmas - \$500; Valentine's Day - \$1,000. If all tickets are sold, parents will receive 50% credit toward tuition.
- **The \$20 Spring Lottery Program**- Lottery will run from May 7, 2012 to September 3, 2012. 1,000 tickets will be available. Sunday thru Friday payout is \$50/day; Saturday - \$100; Mother's Day & Father's Day - \$250; Memorial Day and 4th of July - \$500; Labor Day - \$1,000. If all tickets are sold, parents will receive 50% credit toward tuition.
- **Gertrude Hawk brochure** sales, both Christmas and Easter – approximately 38% depending upon volume sold.
- **Gertrude Hawk Candy Bar Sales, New for 2011-2012**. Numerous families asked that we add candy bar sales to our program. We are targeting the month of October to sell boxes of chocolates. For each box sold the family will receive \$20 off tuition. Families will need to request candy and will be responsible for selling the whole box.
- **Cougar Cash Sales** – Credit will be given on a monthly basis beginning with the month of September, 2011 (will be credited at the beginning of October). Credits earned in July & August, 2011 will be credited at the beginning of September.
- **Night at the Races** – Held in January. Information will be sent home detailing how credit is earned prior to the event.
- **Race for Cougars** – Our Computer lab is in need of upgrading in order to support the programs that our students use daily. In addition, we would eventually like to install Rosetta Stone which is a language software program. This will allow our students to once again be exposed to a foreign language. This program is also costly. For this reason, this year, 75% of the proceeds from the Race for the Cougars will go towards upgrading the computer lab and 25% will be credited to parents as tuition reduction. Consequently, every student will benefit because all students in all grades use the computers in the lab. Please support this program so that we can offer our students updated technology on a regular basis.
